

## WEB SITE TERMS OF USE

### Welcome to the Natural Gas Association of Georgia NGAG Web Site.

The website located at [www.ngaofgeorgia.org](http://www.ngaofgeorgia.org) (the "Web Site") is owned and operated by the Natural Gas Association of Georgia, Inc.
